The most memorable part of the convention for me was a visit to the Multnomah County Registrar Recorder County Clerk. Oregon citizens vote by mail only—no polling places. We saw the procedure they use to send out, receive and process mail in ballots. It's complicated and fascinating, much like the system the City of Burbank uses for its all mail in elections.

### VOTER SERVICE

A core mission of the League of Women Voters is bring people into the political process. One way to do that is to register voters. We participated with the Los Angeles League in World Wrestling Entertainment, "Smack Down Your Vote" at Universal Citiwalk. We also had successful voter registration tables at St. Joseph's Urgent Care, Burbank Adult School, Warner Bros, Providence St. Joseph's Hospital, and the Atwater Village Community Day. **Connie Wilson, Anna Rundle, Gwen Cochran, Joan Hardie, Rosa Frommer, Mary Dickson, Florence Dommies, Mike Chapman** and **Monica Marquez** manned (and womaned) the tables.

On May 3, 2008, **Tom Carson, Mary Dickson** and **Monica Marquez** taped a pro and con presentation on the propositions on the June 3, 2008 ballot. The City of Burbank graciously donated its time and City Council facilities for the taping. The tape has run frequently on Burbank TV 6.

We distributed 1500 Pros and Cons election guides to libraries in Glendale and Burbank.

## REPORT ON NATIONAL IMMIGRATION STUDY

The Board of Directors approved participation in the national study of immigration of LWVUS. Our local efforts began with an initial Immigration Study Committee meeting on June 24, 2007. In contrast with our last two studies, which were addressing issues at the local community level, we started out with consensus questions developed by LWVUS, as well as significant resources on the immigration issues which are available on the LWVUS website. The Committee met a number of times over the summer and in the fall to identify avenues of research, to share the results of research and to discuss the consensus questions to achieve a better understanding of the issues involved.

During the entire process, the Committee also engaged in outreach to the members regarding the study. There were a number of articles in successive issues of the Voter to keep members apprised of our progress and inform the members of where to find resources to conduct their own research. Many of our members attended a county League workshop on immigration in Pasadena. And last but not least, various immigration issues were identified and discussed with the membership during an exercise at the League's annual event at Gordon Biersch in August 2007.

Due to the number and complexity of the national consensus questions, the Immigration Study Commit-

tee split up the questions and held the two consensus meetings for our League in October and November, with excellent attendance and participation. The results were presented to the Board of Directors at their January meeting, and then submitted to LWVUS shortly thereafter. The nationwide results of the Immigration Study were approved in March by the LWVUS Board of Directors, and are available on the LWVUS website.

Overall, our committee members did an outstanding job, while thoroughly enjoying their work! They included: **Chris Carson, Gwen Cochran, Dick Domes, Florence Domes, Nancy Burnet Kent, Monica Marquez, Di Rodriguez, Anna Rundle, Georganne Thomsen, and Connie Wilson.** All worked very hard in their research, our committee discussions and making presentations at the consensus meeting. They are all due thanks and commendations for a job very well done!

## ACTION

### Our Democracy Depends on Your Participation!

#### LWVUS

Our League responded to LWVUS Calls to Action in the areas of D.C. Voting Rights, Civil Liberties, Campaign Finance/Ethics Reform, and Natural Resources. The continued growth of the number of members on the LWVUS E Action list makes this more effective with each year.

#### LWVC

Redistricting: members gathered signatures for the California Voters FIRST redistricting initiative throughout our communities.

HEALTH CARE: members participated in public events with the It's Our Healthcare coalition to spotlight the need for effective health care reform. We also responded to several LWVC Calls to Action on bills in the legislature in support of SB 840 and opposing bills that would have made it more difficult to achieve universal single payer health care.

CAMPAIGN FINANCE REFORM: members re-

sponded to several LWVC Calls to Action to the legislature and the Governor opposing a bill that removed the authority of local jurisdictions to regulate donations to candidates.

The conversion of LWVC Calls to Action to an E Action list similar to LWVUS will make it much easier for members to respond to LWVC requests.

### **LWV Glendale/Burbank**

**SUSTAINABILITY:** Our League continued its efforts to encourage the City of Glendale to adopt LEED (Green Building) standards for new construction.

**Nancy Kent** maintains a watchful eye on the efforts and works with city staff to accomplish our goals.

**ELECTIONS:** Our League successfully supported a Glendale ordinance that would require all applications for absentee ballots to go directly to and from the City Clerk to voters. Individual candidates, parties, and other organizations are no longer allowed to send and process such requests to and from voters. This will streamline the voting process, make less work for the City Clerk, and eliminate delays in voters receiving and returning their applications for absentee ballots. It also has the effect of making it less costly for candidates without a great deal of money to more effectively compete in campaigns.

**CAMPAIGN FINANCE/ETHICS REFORM:** In Glendale, our League is leading the drive to enact contribution limits in City Council races. We held an informative, well attended forum featuring speakers from Burbank, Los Angeles, Glendale, and the Center for Governmental Studies to give perspectives on how limits work in other cities and how they might work in Glendale. In Burbank, we are supporting an ordinance which would require paid lobbyists to register with the City. The local Action campaigns are still a work in progress. We will continue our advocacy this coming year to achieve meaningful reform in both cities.

Our local Action campaigns certainly energized the League. Our President and Board members spent many hours preparing testimony, waiting to speak at public meetings, and effectively representing the League. Many individual members supported the Board's official campaign by speaking as individuals, writing letters to the newspapers, and sending emails to Council members in both cities to make our voice heard.

### **MEMBERSHIP**

Increasing membership continues to be a priority for the League of Women Voters. In 2007, the League of Women Voters of the United States launched its Membership Recruitment Initiative (MRI). The focus of the initiative was to recruit new members from the ranks of the recently retired. Five Leagues across the US were chosen to participate. Glendale/Burbank was not among those selected.

However, in 2008, the League of Women Voters of California took up the call to increase membership. Renamed Membership Growth is Key (MGIK), a number of local Leagues were chosen to participate. Glendale/Burbank is one of the participating Leagues. The goal is to increase membership by 5% by November 2008.

A membership committee has been formed. Board members are encouraged to carry membership brochures with them at all times, and to encourage people to join.

An integral part of the program is known as the "ask." There are many people who would be interested in joining the League, but don't really know how to do so. To make finding us easier on the internet, we purchased the domain name <http://www.lwvglendaleburbank.org>. This is much easier to say and remember than our old name.

In public presentations, the President has incorporated the "ask." In a couple of sentences, She gives information about joining the League and our web address. This is helping us to focus on recruiting members.

The State League assigned us a Membership Advisor to help us focus our efforts. Membership Coordinator Anna Rundle and the President attend monthly meetings by telephone with our Membership Advisor.

Our overall progress to date has been mixed. While we have gained new members, we have lost members as well. We will continue to work toward our goal.

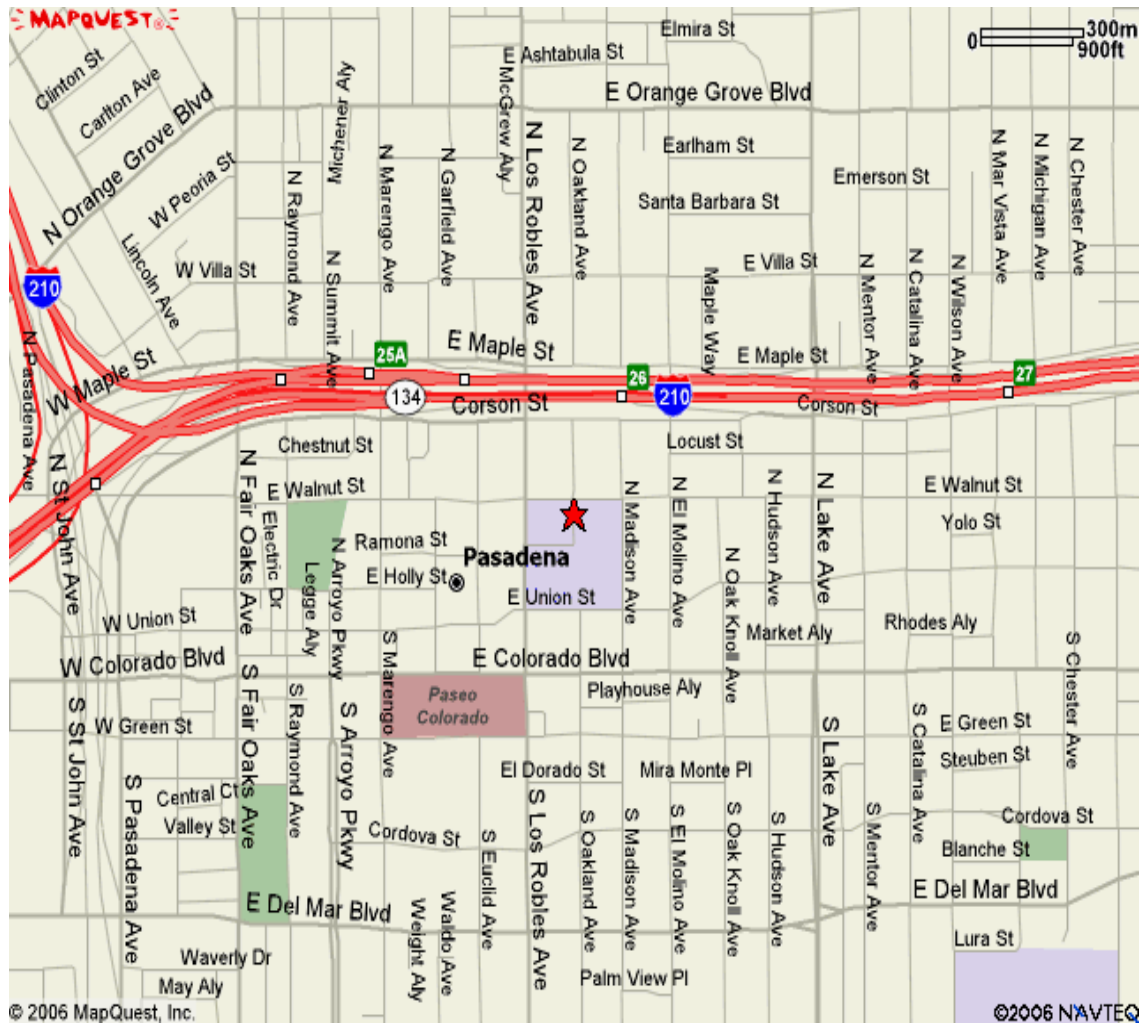

# A Report from Convention

---

THE LEAGUE OF WOMEN VOTERS of the United States Convention took place from June 14-17, 2008 in Portland, Oregon. There were over 600 voting delegates from all over the United States and the District of Columbia.

Among the important accomplishments of the convention was the passage of next year's budget. The members also adopted a Per Member Payment (PMP) of \$28 for fiscal year 2008-2009, and \$29.20 for 2009-2010.

Numerous resolutions were offered at the Convention. Here are some of the important resolutions approved:

- Health Care program to educate members and communities in order to be better prepared to do health care advocacy as needed.

- Motion to adopt a "Multi-Level Education and Advocacy Campaign to promote solutions to global climate change" as an amendment to the proposed program.

- Motion to move adoption of the non-recommended study item entitled: "The advisability of using the National Popular Vote compact among the states as a method for electing the President."

- Motion "Be it resolved that within 12 months, LWVUS redesign its fundraising requests so they cannot be misconstrued as membership recruitment or dues notices. Be it further resolved that: LWVUS enlist the help of representative state and local Leagues to review or revise any fundraising or recruiting letters.

- Motion to adopt the LWVUS Board recommended Program to retain all current LWVUS Positions in the areas of Representative Government, International Relations, Natural Resources, and Social Policy.

Motions defeated included:

- Motion to move for adoption of the Resolution regarding setting of LWVUS action priorities. Be it resolved that: LWVUS shall formulate proposed action priorities, with rationale and pros and cons, which shall be sent to the presidents of state Leagues and ILOs (Inter League Organizations) at least one month

prior to the Convention. At Convention the LWVUS Board shall present its recommendations for action priorities. Convention delegates may propose additions, deletions and modifications to the LWVUS proposed action priorities. The Convention shall adopt action priorities for the biennium by majority vote on each item presented to it. If circumstances emerge requiring a change in action priorities, LWVUS will notify state Leagues and ILOs of the reasons for the change in priorities as soon as reasonably possible."

- Motion to move for adoption of the following resolution: Be it resolved that, the League of Women Voters of the United States establish a Task Force on Nuclear Arms Control and Disarmament composed of experts drawn from the membership of the League, in accordance with LWVUS task force guidelines, the purpose of which is to review the adequacy of the League's positions in the current geo-political era, to educate the membership about the issue, and, if necessary, to make recommendation to the 2010 LWVUS Convention..

- Motion to move for adoption, Be it resolved that: LWVUS will use the following criteria for advocacy: support durable privacy protecting paper ballots that are easy to audit and recount; support statistically valid, random audits after every election. Further resolve that LWVUS establish a list-serve on election systems.

Caucuses attended included:

- Massachusetts Healthcare Reform: Miracle or Mirage (the opinion of the presenters was that the reform package has been unsuccessful)

- Vote 18 (a program for high schoolers to encourage them to vote)

- Men and other Minorities in Today's Modern League (a program describing how one League succeeded with a male President)

Speakers included:

- Women as Political Leaders. Barbara Roberts, First Woman Governor of Oregon 1991-1995

- Presentation of Honorable John Kitzhaber, Governor of Oregon, 1994-2002: The Unfinished Business of the Baby Boom Generation: Health Care for the 21<sup>st</sup> Century

# Budget “Reform” Lacks Vision

## Statement of the League of Women Voters of California

The League of Women Voters of California is disappointed that Governor Schwarzenegger’s proposed revision to the 2008-2009 state budget fails to address the needs of Californians in the present crisis or to lay out a path to a sounder fiscal approach in the future. In addition, the basic premises of our government call for representative government and a balance of power between the legislative and executive branches, and the changes to the budget process proposed by the administration violate those premises.

We understand that painful cuts and some borrowing are likely to be needed this budget year even if new savings or revenues are agreed on, because those savings or revenues might not take effect soon enough to contribute to a balanced budget and avoid a cash flow problem this summer.

However, to simply say that we have no money and that Californians will have to live with budget restrictions in the future, no matter what the consequences are, is short-sighted. We have one of the largest economies in the world, but it can only continue to thrive if we put in the resources necessary to produce a healthier, better educated population and a sound infrastructure. We believe that Californians want a better future for themselves and their children, and that we can come together on a plan to get there.

The Governor says we must live within our means, but he himself cut back our revenue when he eliminated the Vehicle License Fee upon taking office and has since proposed nothing to take its place, even though that cut now represents about a \$6 billion gap in our “means.” At the same time, the proposed budget would impose severe cuts on the poorest and most vulnerable, who do truly have to live within their means. We think California can do better than that.

In 2005 we opposed Proposition 76, which would have given a Governor more power to cut the budget and would have reduced funding for education, and it was soundly defeated by the voters. Now, the administration is attempting to force an even harsher proposal on the legislature by tying it into the proposed budget, even though no legislator has so far been willing to introduce it as a bill. The legislature would be better occupied reversing billions of dollars in tax cuts and tax loopholes it has enacted in recent years.

As the proposal has been described, it would give a Governor unprecedented power to override existing laws and regulations, whether the legislature agreed or not, in order to make whatever budget cuts he or she wanted when estimated expenditures exceed estimated revenues. It would also impose a formula for a “revenue stabilization fund” that would limit the state’s ability to spend available revenues even in years of substantial growth and would probably mean that we would face more years of shortfalls and added budget cuts with no consideration of public needs. Calculations used for the proposed revenue limit and to authorize unilateral spending cuts by the Governor would apparently be based on estimates of projected revenues by the Director of Finance rather than on actual revenue collections.

This proposal would make a shambles of our system of checks and balances, and in the process destroy any vision of a better future for our children.

## What You Can Do About the California State Budget

In the May 2008 Revision to the state budget proposal, Governor Schwarzenegger has again proposed a “cuts-only” budget that would be devastating to California’s families and our state’s future. The League of Women Voters of California strongly opposes the “cuts-only” approach to the budget.

The following points will assist you in writing letters to local newspapers, posting comments to blogs, talking to friends, and contacting your elected representatives.

1. Ignoring the concerns of millions of Californians, the Governor’s revised budget simply proposes **more of the same**, making deep cuts to health care, senior and disabled services, schools, and investments in children.

2. The revised budget cuts are **even deeper** than in the Governor’s original proposal in some critical areas, such as health care. If enacted, these cuts would jeopardize the safety and security of California’s children, families, seniors, and the disabled.

## LEED Update: Glendale

ON JULY 1, 2008, all the members of the Glendale City Council directed staff that the Council wants to have sustainable building requirements ASAP—they do not want to wait for the process for updating Glendale’s General Plan to start this.

The City Council gave direction to staff that points toward:

- a LEED Silver requirement for MUNICIPAL buildings
- a LEED Silver requirement (rather than only incentives) for PRIVATE projects

(LEED stands for The Leadership in Energy and Environmental Design Green Building Rating System.)

The issue of whether the U.S. Green Building Council (USGBC) or city staff will be the ones to verify that LEED has been achieved has not yet been decided.

Glendale/Burbank League member **Nancy Kent** has attended many Glendale City Council meetings to keep apprised of developments on this issue.

3. The proposed cuts will **impact California families in multiple ways**, often compounding problems. Communities will receive cuts to their local schools, hospitals, in-home care programs for seniors, and foster care services for kids. The Governor’s short-term approach will have long-term, negative human and fiscal consequences.

4. The Governor’s budget also includes a **distracting “power-grab” proposal** that already has been overwhelmingly rejected by California’s voters and that doesn’t address the real concerns of California’s families. In fact, it undermines our system of checks and balances by giving the Governor unprecedented power to make cuts without approval from our legislators.

5. Our legislators and our Governor need to find **real solutions** that don’t jeopardize the education of our children, health care for the sick and elderly, or the environment.

6. We believe that California is ready to **invest in our shared future** and seek balanced solutions. We are **working together with all Californians** to hold our Governor and legislators accountable and make that happen.
